

Privacy Policy

Clever Print Lda is strongly committed to protecting your privacy while interacting with our content, products and services. We want to provide a safe and secure environment for you.

Clever Print Lda is concerned about protecting the safety and privacy of people using our services.

The purpose of this Privacy Policy is to tell you what kind of information we may gather about you when you visit our site, how we may use that information, whether we disclose it to anyone, and the choices you have regarding our use of, and your ability to correct this information. Our policy allows you to choose what kind and how much information you provide to us and to control how we use whatever information you give us. Our goal is to provide you with a satisfying experience while allowing you to control your privacy and to give you a means to voice any questions or concerns you may have.

This policy applies only to Clever Print Lda and not to other companies' or organisations' websites to which Clever Print Lda is linked.

Collection of information

Information is collected from you primarily to make it easier and more rewarding for you to use our services. Depending on the service you are accessing, you could be asked to provide information such as your name, email address or information about what you like and do not like. It is entirely your choice whether to respond to these questions or not.

Clever Print Lda collects two types of information. The first type is anonymous information. For instance, we may collect information to tell us how many people visit this Privacy Policy, but we do not know their names, where they live or their date of birth - they are 'anonymous' to us. Many of the individuals who access our services are anonymous to us.

The second type of information that Clever Print Lda collects is personal information. Clever Print Lda will collect personal information that lets us know the specifics of who you are such as your name, email address, or postal address, *when you provide it to us*. With this information, Clever Print Lda can provide a variety of personalised and enhanced services that are not available to anonymous users. We hope that you will find it beneficial to provide individually identifiable information about yourself to us because it will make our services more valuable to you.

Sometimes, we may specifically ask for personal information about you when you request detailed information. Certain information may be required, such as your name, internet address, postal address, company details, in order to provide that information or product to you. This information may also be used to inform you of additional products and services which may interest you. You can choose not to receive such information when you are requesting product information or services on our website.

How much of your personal information that you choose to disclose to Clever Print Lda is completely up to you. The only way we know something about you personally is if you provide it to us.

Use of personal information

Clever Print Lda will only use the personal information you have chosen to provide us for the purpose for which you provided it, and only for internal use and for internal commercial purposes. Clever Print Lda will not use it for any other purpose without your consent.

Under no circumstances will Clever Print Lda sell or receive payment for licensing or disclosing your personal information.
